The Mayor's Memo

Carrie Kirk, one of our council members has taken on the task of organizing a cleanup project for Providence Canyon. We've had a lot of complaints recently and as the land is US Forest Service and State property, the City has no jurisdiction. Kudos to Carrie for being willing to take on the project. See the story on page 4.

One of our Providence residents is a Forest Service employee who's daily routine is to check the condition of the canyon. He's alerted us to the abuse and the nature and extent of the trash left behind

If we keep our canyon well maintained, it sends a message to visitors that it is not a place to abuse and leave their trash.

More on High-Bandwidth Fiber

The July council meeting included a discussion and vote on moving forward with a fiber network project. The council voted unanimously to instruct the city staff to gather information necessary to proceed. There are a number of

issues that will be further discussed and decided before any project related investments are approved.

One of those decisions is to agree on a business model. The council chose to narrow consideration down to a "utility" or "subscription" model. The utility model provides a connection to each residence which a monthly base charge. The subscription model only constructs a connection for those households that "subscribe" to the service.

The utility model is less costly to construct as all of the connections are made at the same time. This model also fully funds bonded debt service from day one. The subscription model constructs connections individually as new users are added.

A fiber connection will allow city residents to have additional choices of service content, internet, phone and entertainment in addition to that offered by Century Link and Comcast.

The project costs are funded with revenue bonds which are paid off with fiber network service fees and do not impact budgeted funds for city streets and other projects.

City Manager

Here is an update of ongoing and planned projects that the council, city staff and volunteers are working on.

Transportation Master Plan

Our Transportation Master Plan project is underway with CRS Engineers working on this. More details will be coming soon.

100 South Widening Project

CRS Engineering was selected to do the engineering and design work on our 100 South project. We will be submitting a grant application to include the engineering plans to the Cache County Council of Governments (COG) for construction costs. The grant application deadline is August 13. After the deadline, all grant applications go through a detailed technical evaluation by the CTEC which scores each application and makes its recommendations to the COG.

The COG, which is made up of all 19 Cache Valley mayors and the county executive reviews the recommendations and determines the final list of applications for approval. The County Council considers the COG recommended list of grant applications and makes final approval. Construction would begin spring of 2021.

Parks, Trails and Recreation Master Plan

We have selected MHTN, a Salt Lake City based planning and design firm to do our Parks, Trails, and Recreation Master Plan. We are currently forming a steering committee to lead the process.

Sewer System Master Plan

We have secured \$30,000 in grant funding for a Sewer Master Plan. We posted a public notice of a Request for Proposals with a deadline of August 14 for submittal.

Cemetery Master Plan

The Cemetery Master Plan project will begin later in the year and likely will progress over the winter.

We hope you will take the time over the coming months to give us your input into each of the master plans so that we can plan and proceed to build Providence to be the community you want it to be.

Resident Comments Addressed

We frequently have notes dropped off, emails sent with suggestions, comments and questions. I am planning to add a regular section each month to address resident inquires for all newsletter readers. I hope you find this useful and informative.

Maps of the City

Often times newsletter articles will describe events, or activities in different parts of the city. This could be road repair or maintenance, FIREWORKS restrictions or other projects. When we do so, we oftentimes reference a link to the city website to view the map that deliniates the areas being impacted.

Printing the city-wide map in the newsletter even on an entire page, geographical features and street names are barely readable. Because of the size of the area covered, the maps are made available on the city website. That way a reader can zoom in on a particular area of interest.

Cemetery Space

There is property just north of and directly adjacent to our Cemetery which is owned by the City of River Heights. It could be a natural fit to expand our cemetery.

Over the years, Providence mayors and councils have had discussions with River Heights City officials about acquiring that property. Offers we have received in the past were deemed by Providence City officials to be one-sided and not in the interest of our city.

Most recently, neighbors in the vicinity of that property have told River Heights officials that they do not want to see the Providence cemetery expanded in their direction as funeral attendees bring too much noise. The mayor of River Heights told me they are planning to build a park, but not accessible from the cemetery.

Fiber Network

Further clarification

The fiber/cable/internet telecommunications business has two segments; the network infrastructure (shielded conduit, copper phone wire, fiber), and content. The content includes internet, phone, television, movies, etc.

In Providence, 93% of residences are Comcast and Century Link customers that are provided both infrastructure (physical connection) and content. There are many <u>content only</u> providers including Comcast and Century Link in some locations.

What we are exploring is bring a technology that uses light waves in place of phone wire and shielded cable. Fiber uses light waves at the speed of light to transfer data. Thus, fiber is a means to increase the volume and speed at which data can be downloaded or uploaded. Therefore, it brings the capability of state-of-the-art and future technology potential to Providence.

One analogy is to think of the streets and roads provided and maintained by the city. You have the use of and services via those streets, but the city does not provide the delivery of product.

Content Options

One benefit of separating the network infrastructure business from the content is it will allow residents more, not fewer options. We will not be "kicking out" existing service providers. Residents will still be able

to keep their current provider and their current telecom options. What additional content providers bring is more competition and potentially better pricing, a win-win for residents.

Technology Advances

Fiber in itself does not bring new technology. It does bring the vehicle for future advances. For example, 5G technology operates in a more data-intensive mode compared to previous technology. In order to do so, fiber currently is the primary technology that allows full use of 5G capability. Future technology may use other means for 5G to connect.

Green Waste

We've heard a lot of resident interest in an expanded green waste program. In the June newsletter, I included an article that talked about turning green waste in to a useable product rather than filling the landfill. There have been some developments I'd like to convey.

Background

In the 1990s, Logan City initiated the green waste program to extend the life of the existing landfill. Adding additional life saves all utility customers by delaying having to share the cost of acquiring another landfill location. In recent years, the Logan City landfill reached near capacity and additional space was acquired in a canyon about 5 miles north of Clarkston.

Fast forward to today, the issue of green waste in the landfill has taken on a more urgent nature. After two years, green waste and other biological material is breaking down and generating methane gas. Since the 1990s when the Logan green waste program was established, the Environmental Protection Agency (EPA) has mandated that when a certain volume of methane gas is generated, a facility to capture the landfill methane must be constructed. This is not an inexpensive undertaking.

EPA Mandate

As I see it, we can make a wise choice as utility customers to collect, process and put as much green waste to use, or pay the price down the road for the convenience of dumping it in the landfill. I consider this similar to the EPA mandating that the City of Logan replace the existing wastewater treatment facility with a complex mechanical treatment plant. Changes to regulations resulted in Logan City to have to spend \$150 million for a new treatment plant and pass rate increases on to customers.

County Council

On Tuesday, July 28 the county council met a second time to consider a recommendation from the Solid Waste Advisory Board to institute a full service collection and processing program to recycle green waste. It would include green waste bins during the April - October season, expand the number of locations of green waste bins, hire additional staff and invest in additional processing and collection equipment. The proposal also would cut the price of recycled material, wood chips, compost, etc. in half. The cost would be \$1.50 per household per month. All Cache Valley mayors and councils expressed a strong interest in the full program.

The council did not act on the recommendation at that meeting. This leaves the Board's recommendation unresolved. The plan was to have the program in place by September 1st. We will continue discussions and hopefully come to a resolution.

Lets Keep Providence Canyon Clean

Council Member Carrie Kirk is organizing a cleanup of Providence Canyon. We have had groups in the past that have conducted cleanups, but the effort has not been consistent. Residents have noticed the trash.

The canyon is part State Department of Natural Resources (DNR) land and beyond the 2^{nd} parking lot is US Forest Service land. The City owns property at the storage reservoir only.

You may have noticed that Providence Canyon could use some clean up. This year it has had a lot of use and a little abuse. Working together we can make a real difference.

We are asking families to pitch in on any date that works for them. You can go to the city office and pick up garbage bags or use your own. Leave the garbage you collect in bags along the canyon road and city crew will collect the bags and take them to the dump a few times during the week.

Garbage bags and popsicles will be distributed at the canyon parking lot on Monday and Tuesday, September 14th and 15th from 7 - 8 PM and Saturday, September 19 from 10 -11 AM.

Property Owner Maintenance of Park Strips & Sidewalks - Trees and Vegetation

As specified in City Code, property owners in Providence are responsible for maintaining the park strip adjacent to their properties and for keeping the sidewalk clear. The following sections are intended to help residents understand their responsibilities

Property owners are required to trim trees and other vegetation so that it does not obstruct the sidewalk or the roadway (PCC 7-1-3.D). Trees are required to be trimmed 8 ft above the sidewalk and 14 ft above the roadway. (PCC 7-1-8.D.5).

Planting or removing trees, where allowed (see section on landscaping), requires a permit from the city. Tree varieties must be from the approved tree list, and must be planted according to the spacing requirements set forth in 7-1-8 (A), and the additional requirements in 7-1-8(D) (see above link for both code sections).

Property owners are required to "maintain the landscaping in a healthy, safe, attractive, and nuisance-free condition" (PCC 7-1-8(A)6)
