Parking

The Holidays are here as well as the season of snow removal so we need to solicit your support in the following:

1. Since our streets are so narrow, it would be great if you would please direct your visitors to park in the visitor parking stalls.
2. As much as possible, we need to save the visitor parking for our friends and guests. If you have overnight guests have them pick up a parking permit located in the clubhouse lobby and hang it on their rearview mirror.
3. If snow removal is underway, all outside parking areas need to be clear. In order for efficient snow removal, please move your vehicle while your area is being plowed. Once the area is cleared you may move your vehicle back into your assigned parking stall.
4. The clubhouse is now open for our residents to schedule events. The visitor areas around the clubhouse (in front, north and south side) need to be kept free so there is sufficient parking for our guests. On the North side of the clubhouse, there are 7 designated stalls assigned to homeowners and marked with a house number. Please ask your guests to refrain from parking in a homeowners' personal parking space.
5. We have limited visitor parking stalls. To be fair to our neighbors, visitor stalls should never be used as overnight parking for permanent resident vehicles, inoperable vehicles, trailers, etc. Please refer to Page 11 of the Rules and Regulations Book. (Revised 4/15/2016).
6. These rules were set up for the benefit of our community. Please be kind and considerate to your friends and neighbors as well as the Management Board who are responsible for enforcing the community rules and regulations. The Board has tried to avoid using towing services or set fines, but for the good of the whole community, and in attempt to be fair to all, we will begin towing vehicles that are violating the parking rules.

No Soliciting

If you are aware of anyone putting solicitations on doors, please remind them there is no soliciting within Cobblestone at Spring Creek. Notices on doors can become a red flag that residents may not be at home. This includes church and community notices. Thank you.

Gathering Room
